The grooming and preparation of all animals for exhibit is the responsibility of the Exhibitor. Exhibitors may receive guidance only from immediate family members, Maryland 4-H/FFA Members and appointed UME Volunteers/FFA Advisors.

Pre-entry is required. YOU MUST USE THE INTERNET ENTRY SYSTEMS FOUND AT www.marylandstatefair.com Internet entries are due July 15th. Exhibitors without internet access should contact their County Extension Educator for assistance. All release forms are to be completed online through the entry system at time of registration. Reminder: you must have completed the Animal Husbandry & Quality Assurance program to be able to exhibit your animals. Check with your county to make sure you are up to date with this requirement.

Division Rules & Regulations:

1. Exhibitors and their exhibits must comply with the "General State Fair Rules & Regulations", "General 4-H and FFA Rules & Regulations", "Animal Rules & Regulations", the "Maryland 4-H Code of Animal Science Ethics", the "Health Regulations for Livestock Exhibited in Maryland", these "Division Rules & Regulations" and the applicable "Section Rules & Regulations".

2. Schedule for 2023:

- a. Beef exhibits received Wednesday, August 23rd, 12:00 noon 9:00pm
- b. Beef exhibits received Thursday, August 24th, 7:00am 12:00 noon
- c. Beef exhibits must be in place by 12:00 noon, Thursday, August 24th
- d. Beef Heifer Check-In –Wednesday afternoon, August 23rd, and Thursday, August 24th, 9:00am to 3:00pm
 All heifers (except Commercial) must be checked in with beef superintendents by 3:00pm Thursday, August 24th
- e. Beef Exhibitor Orientation 3:00pm, Thursday, August 24th (Swine Show Ring)
- f. Beef Steers, Commercial Heifers and Dairy Steers Weigh-In 3:30pm, Thursday, August 24th (scales outside north end of Cow Palace)
- g. Beef Showmanship 12:00 noon, Friday, August 25th
- h. Beef Heifer Show 9:00am, Saturday, August 26th
- i. Beef Steer Show 7:00pm, Saturday, August 26th. Beef Steer Selection for the Youth Livestock Sale will take place immediately following the Beef Steer Show.
- j. 4-H/FFA All-Star Showmanship for Market Livestock- 5:00pm, Sunday, August 27th
- k. 4-H/FFA Beef Released (except for Livestock Sale Steers) 8:00pm, Sunday, August 27th
- Youth Livestock Auction 7:00pm, Monday, August 28th
- 3. Entries: Entries will be received on Wednesday, August 23rd, from 12:00 noon to 9:00pm; and Thursday, August 24th, from 7:00am to 12:00 noon. All beef animals must be in place no later than 12:00 noon on Thursday, August 24th. Refer to "Schedule of Events" and "4-H/FFA Exhibit Entry Information" for additional information. DO NOT BRING TACK/DECOR BEFORE Tuesday, August 22nd. DO NOT BRING ANIMALS BEFORE 12:00 noon WEDNESDAY, AUGUST 23rd! Tie-outs will be available in a new location for 2023 and are available on a first-come, first-serve basis.
 - a. Only steers with <u>purebred</u> bloodlines can show in Angus, Hereford, and Shorthorn steer classes. The All Other Breeds/AOB Steers classes includes all other registered/recorded breeds. Breed Association <u>registration papers</u> are required at weigh-in for all Angus, Hereford, Shorthorn and AOB steers, and <u>steers must be tattooed prior to arrival on fairgrounds</u>. All steers without breed association registration papers will show in the crossbred steer division.
 - b. Steers will be shown by breed and weight. **Indicate breed on entry form.** Steers must weigh a minimum of 1,100 lbs. All animals will be weighed and divided into classes at the superintendent's discretion. Number of classes may vary among breeds. **Re-weighing will NOT be permitted. Steers must be born on or after January 1, 2022**
 - c. For heifers, indicate breed, date of birth, registration number, sire, and dam on entry form. Commercial heifers will be shown by weight, not by age.
 - d. Exhibitors are limited to not more than 5 steers and may not win more than 2 premiums in any one class. Exhibitors may enter up to 2 heifers per class per breed including Commercial heifers.
 - e. Exhibitor Orientation will be held on Thursday, August 24th at 3:30pm in the Swine Show Ring. Steers and commercial heifers will be weighed at 3:30pm, Thursday, August 24th, following the Exhibitor Orientation, on the scales outside the north end of the Cow Palace.

 Commercial heifer tags will be checked when heifers are weighed in.
 - f. Market steers must have a minimum average daily gain of 2.0 lb. to be eligible to show and sell at the Maryland State Fair in 2023, (in addition to meeting the 1,100-lb minimum weight). Starting weight and date must be verified by the County 4-H Extension Educator / FFA Advisor. Please see Youth Livestock Sale Rules found in 4-H/FFA Division X, Section XIV for additional information pertaining to beef steer sale animals.
 - g. The Grand Champion Beef Steer MUST sell in the Youth Livestock Sale on Monday, August 28th. Reserve Grand Champion Beef Steer may sell (but is NOT required to sell) in the Youth Livestock Sale. A total of 12 beef steers (including the Grand Champion Beef Steer and the Grand Champion Dairy Steer) will be sold in the Youth Livestock Sale. Selection of steers for the Youth Livestock Sale will take place immediately following the Beef Steer Show Saturday evening, August 26th. Refer to Youth Livestock Sale Rules found in 4-H/FFA Division X, Section XIV rules for additional information pertaining to beef steer sale animals.
 - h. Steers and heifers must be <u>dehorned</u> and <u>healed</u>. Steers are to be castrated and healed except in class B21. For safety reasons, entries for animals not meeting these criteria will not be accepted.
 - Commercial heifers are <u>unrecorded</u> crossbreds. All current rules apply. These heifers will be shown by weight and divided into weight classes. COMMERCIAL HEIFERS MUST BE TAGGED WITH AN OFFICIAL MARYLAND 4-H/FFA TAG BY JULY 1, 2023, and exhibitors must have a copy of their 4-H livestock registration form at check-in.
 - Substitutions: Exhibitors may substitute one animal for another.

4. Ownership:

- a. All steers must be the bona fide property of the exhibitor by January 1 of the current year. All steers must be tagged with a MD 4-H or MD FFA livestock tag or an official GFF (Great Frederick Fair) livestock tag.
- b. Breeding heifers must be the bona fide property of the exhibitor and must be <u>solely owned and registered in the name of the exhibitor only</u> by July 1, 2023. Cows and calves in the cow/calf class must be registered in the name of the owner and both must be tattooed. Registration certificates and tattoos will be checked by the superintendent. Entries received with "Papers Pending" will not be accepted. Cows entered in the Cow/calf class will not compete for Champion Heifer. A Supreme Champion Cow/Calf Pair will be selected prior to selection of the Supreme Champion Heifer.

- c. Ear tattoos must be legible and conform to the respective BREED ASSOCIATION REGISTRATION CERTIFICATE. Exhibitors must clean the animal's ears (free of wax and/or dirt) prior to check-in of registered heifers and purebred registered steers.
- d. Bred and Owned Classes: Exhibitors in the Bred and Owned Classes in 4-H/FFA animal divisions must be the breeder and the first and continuous owner of the animal entered. "Breeder" is defined as the recorded owner of the dam at the time of breeding/service. "First Owner" is defined as the recorded owner of the dam at the time the animal was born.
- 5. Proper attire must be worn during the showmanship classes, steer show, heifer show, and the livestock sale. Refer to the 4-H AND FFA ANIMAL SHOW ATTIRE section under the GENERAL STATE FAIR RULES & REGULATIONS for show attire requirements.
- 6. **County Groups -** A county group shall consist of 4 animals (4 steers or 4 heifers) owned by four different 4-H and/or FFA members. Each county is limited to 2 entries. Exhibitors may only show in one county group.
- All animals that compete in market or breed classes MUST compete in the breed and overall champion drives. Failure to compete will eliminate the exhibitor from Maryland State Fair 4-H competition the following year and will result in the forfeiture of all premiums in the current year.
- 8. <u>Exhibitors must show their own animal.</u> Refer to the "Animal Rules & Regulations" section of the GENERAL STATE FAIR RULES & REGULATIONS for more information and details.
- 9. ALL 4-H BEEF DEPARTMENT SHOWS (SHOWMANSHIP, STEERS, & HEIFERS) WILL BE UNFITTED. This means animals can only be washed and blown out with NO adhesives, show foam, coloring agents, paints, oils or other fitting aids allowed to prepare cattle for show. Exhibitors ARE allowed to use hair and skin care products and conditioners (such as Revive, Kleen Sheen) as part of the regular daily grooming and hair maintenance of their beef cattle while at State Fair. Animals may be subject to being wiped with a white towel, cloth, etc. as they report to the make-up area and show ring.

BEEF SHOWMANSHIP - Section 1

Section Rules & Regulations:

- 1. Pre-entry is required. Internet Entry Forms are due to the State Fair by July 15, 2023. Exhibitors will compete according to their 4-H Age (age as of 1/1/23). Classes may be further divided at the sole discretion of the Superintendent. An Exhibitor is limited to showing one (1) animal (either a steer or a heifer). Animals must be owned by the exhibitor and entered in a breeding or steer class in this division. Refer to "4-H and FFA Fitting & Showmanship Regulations" for additional information.
- 2. Participants in Showmanship will be judged strictly on their showmanship in the ring. Judging Criteria: Performance in the Show Ring (60), Knowledge (30), and Personal Appearance (10). Showmanship animals <u>will not be fitted</u> and may only be washed, clipped and blown out prior to entry in the ring. No fitting products (oil, show foams, adhesives, coloring agents, paints, etc.) are to be used on the animal. Judge may ask questions of the contestants during this class.
- Showmanship Grand Champion will be eligible to participate in the 4-H/FFA All-Star Showmanship Contest for Market Livestock on Sunday, August 27, 2023 @ 5:00pm. See Division X, Section XV- 4-H/FFA All-Star Showmanship Contest for rules.
