Open to children 17 years of age and under as of December 1, 2023. To be judged on the child's ability and knowledge of cleaning and grooming procedures, as well as showmanship. Age to be taken into consideration. Classes will be shown individually starting with Children under 8 years of age. Horse/pony may be used by more than one exhibitor in different age groups. No foals allowed. **Adults or helpers may accompany children into the ring to carry their grooming equipment but must leave before the judging begins.**

If a child needs assistance in the ring during the contest, the Ringmaster will assist. The ponies/horses will be tied to the fence. The children must have their own grooming equipment with them. Children should be clean, tidy and dress to groom, not to ride. Braiding will not be considered in the judging of the class.
