

SECTION H - CHRISTMAS TREES

Entries will be received in the Cow Palace due to construction of the new Farm & Garden Building.

Instructions:

1. All trees must arrive Saturday, August 16, 2025, time 11AM to 3PM. Trees will be judged the same day.
2. All trees must be plantation grown and must be from 5' to 8' in height from the bottom of the handle to the tip of the leader.
3. All trees must be sheared.
4. All growers who enter the National contest "shall be 'Members in Good Standing' of the NCTA and their respective affiliated chartered Association **at the time of affiliated/state contest** to be eligible to enter the NCTA contest." NCTA membership must be active prior to the state contest to maintain eligibility for the National contest. It is no longer permissible to compete in the National contest by joining NCTA right before the National contest.
5. Stands will be provided. You do not have to return at close of the fair for your tree. Fair personnel and section superintendent will dispose of the exhibit.
6. Exhibitors are limited to one (1) entry per class.
7. The Fair is not responsible for lost or damaged items.
